Report from the Chairman

The Chairman read out his annual report which is appended to this document.

Treasurers' Report and Presentation of 2023 Annual Accounts

The annual accounts for year ending 31 December 2023 were received and considered. The committee was advised that the accounts had been prepared by the treasurer in line with standard accounting practice and have been audited, certified as accurate and given a clean bill of health by the auditor.

Key points are set out below:

- 1. Hall hire fee receipts increased by £758.00 from 2022.
- 2. The biggest expense for 2023 was the kitchen refurbishment costing a total of £39,692 with the Parish Council donating £24,437.00, the Buxhall Community Council donating £500 and a grant from Mid Suffolk District Council of £11,030.26 (payment received 29.01.2024)
- 3. Fund raising in 2023 increased with the quiz nights raising £802 and the new monthly Tea Rooms raising £1,736.
- 4. The main repair for the year was the roof £13,897 which the Parish Council reimbursed the Village Hall for.
- 5. Little Ernie net income for the year is £864 slightly up on last year.

Following a nomination and election process it was resolved to appoint: Wayne Greenlaw, Emily Byam, Hilary Hall, Sally Greenlaw and Keith Proctor as Trustees to serve until the annual meeting 2025.

Co Option of Trustees

After a further nomination process, Mim Proctor, Gill Bottomley and Claire Farrell were coopted as Trustees to serve until the annual meeting 2025.

Election of Representatives

It was noted that the following had been nominated to represent their organisations on the Buxhall Village Hall Committee; Val Lord for Buxhall WI, Ben Nickell for Buxhall Community Council and Mike Drury for Buxhall Parish Council. It was resolved to accept the nominations.

No new village groups had applied for representation on the committee. It was noted that the Parochial Parish Council no longer has a representative and it was suggested that they be asked.

Eliaibility

All members confirmed and signed a declaration as to their eligibility to be members of the Buxhall Village Hall Management Committee and their willingness to act in the trusts of the Buxhall Village Hall Trust Deed.

The next meeting of the committee was agreed as Thursday 25 April 2024 to follow the AGM.
